Race dates: December 15 (Classic) / January 5 (Freestyle) / March 8 (Classic)

Please note: Trail fees are **NOT** included with race registration. The US Forest Service requires that all Spam Cup participants have valid Rendezvous Ski Trail passes in their possession. Trail passes can be purchased at the trailhead and USFS personnel will be present to enforce the trail fee regulations. Daily passes are \$5.00, season passes are \$25.00 and family season passes are \$50.00. Please bring exact change or a check made out to "USFS".

Race entry fees: \$10.00 for adults, \$5.00 for age 18 and younger (checks payable to WYSEF, entry fee only).

Race Day Registration and Bib Pickup: 10:00 – 10: 45 AM at the Biathlon Range.

No registrations will be accepted after 10:45 AM. Please try to register early and arrive prior to 10:45 so that the race can start on time.
